

MAKE THIS ELECTION A GREEN ELECTION

The Election Commission of India, in its Model Code of Conduct for the 2019 Lok Sabha Elections, has proposed to promote the usage of eco-friendly materials during the election campaign. The Hon'ble High Court of Kerala vide interim order No. WP(C) 7193/19 dated 11.03.2019 has banned the use of PVC flex boards and other non-bio degradable materials as campaign materials in Kerala. The Chief Electoral Officer, Kerala has released guidelines for conducting the election process in an eco-friendly manner by following green protocol procedures. Political parties and the public may have doubts regarding the complete and effective implementation of these orders. This handbook is intended to clear those doubts.

Can't we then, erect any hoardings or boards?



The ban is not on erecting hoardings or boards, but on using non-bio degradable materials for making them, which are harmful to the environment. Boards printed or written on cotton cloth, boards printed on the newly developed medium of paper and cloth, etc are now easily available in Kerala. The PVC flex can easily be replaced with the paper & cloth medium as it can be printed using the same flex printing machine instead of PVC flex. Besides these items, natural and eco-friendly materials like bamboo, reed, palm leaf, spathe of areca palm, coir/ palm/grass mats etc can be used for making attractive boards and other election campaigning materials. Digital boards can also be displayed at permitted spots.





How can flags, festoons and other decorations be done?

Flags, festoons and other decorative items can be made either in cloth or in paper.
Flags are usually made of cloth. Let us decide to avoid synthetic cloth and use only cotton cloth for this purpose this time. Festoons can also be made using cotton cloth or paper.



Can we avoid bottled drinking water during house visits and candidate's campaigning tour?





Surely. The squads going for house wise campaign can keep a steel water bottle with them, so as to avoid buying bottled drinking water. Water dispensers and steel cups kept inside the vehicle of the candidates can help avoiding thousands of disposable cups and water bottles.




Anything else to be taken care of in the campaign vehicles?

Yes. Use only eco-friendly materials to decorate the vehicles. Materials such as PVC flex, plastic and thermocol should be completely avoided. Instead, cotton cloth, paper and other environment friendly materials can be used.



What else needs to be taken care of during public meetings of candidates?





Ensure that the garlands used for receiving the candidates are not made of plastic. Garlands made of flowers, cotton yarn and shawls etc can be used instead. Let the affection towards our mother earth exist along with the affection towards our candidates.



What precautions are to be taken for maintaining green protocol while serving food during the election campaign?

Parcels containing plastic packaging of food, disposable cups and plates made of paper, plastic and thermocol are to be avoided. Steel plates, glass tumblers etc can be used instead. These items are easily available on rent. If all those who are engaged in election campaigning across Kerala act in this manner. tonnes of non-bio degradable material that destroy the environment can be avoided. This in turn will avert the chance of an epidemic outbreak during the next monsoon season. The election expenditure can also be brought down by a great extent by this.



Can the political parties do anything to spread the message of green election?





Of course, they can.
Green messages can be included in the notices and pamphlets printed for distribution as part of the election campaign.
The candidates can also mention about their unique environment friendly campaigning methods or the environment friendly activities that the candidate will take up if elected.



Yes. Of course. But the habit of pasting PVC stickers on walls and pasting photos of candidates along with the election graffiti (wall writing) is increasing nowadays. These are to be completely avoided. Let the graffiti be done using brush and paint.

Is there any restriction for using arches made of cloths?

Though the arches are usually made of iron/aluminium/wooden frame and cloth covering, the letters affixed on them would be made of thermocol, which are not even recyclable. Let us avoid them this time, and ensure that the arches contain banners written on cotton cloth only and not with thermocol or PVC flex or plastic.





Is there anything to be taken care once the elections are over?



Sure. Even when the election campaign is done using only environment friendly materials, it may cause pollution if the campaign material is not properly disposed after the elections. Those who have installed the boards, banners, flags and festoons etc shall remove them as and when the election is over, segregate them and hand them over to the Local Self Government authorities. The Local Self Government authorities will send them for proper disposal. If all of us act this way, we would create another history. Let us create a new model for the entire nation, by collecting even the thrown away photo voter slips and send them for proper disposal or recycling.





Can political parties and the public get help from any agencies?

Of course. The Chief Electoral Officer, Kerala has entrusted Haritha Keralam Mission and Suchitwa Mission to set up facilitation units from State level to Local body level for assisting the political parties, officials and the general public in maintaining green protocol through out the election process. Doubts regarding this can be cleared by contacting the district mission officers.

Do's

- Boards, banners and hoardings containing cotton cloth, paper ,reed, bamboo, palm leaves etc.
- 2. Water dispensers, steel bottles, steel cups, glass tumblers, steel plates etc
- 3. Cloth or paper flags and festoons, cloth arches
- 4. Food packed in steel vessels or plantain leaves
- 5. Flower garlands, cotton yarn and shawl for receiving the candidates

Dont's

- 1. Boards, banners and hoardings containing plastic
- All types of disposable items including bottled water, paper / plastic cups and plates
- 3. Plastic flags and festoons, arches using plastic or thermocol
- 4. Food items packed in plastic sheets and containers
- 5. Plastic garlands



Hon'ble High Court Order: Direction to use only eco-friendly materials for the purpose of advertisement during ongoing election campaign in the state.

This petition coming on for admission upon perusing the petition and the affidavit filed in support of WP(C) and upon hearing the arguments of SRI.M. KANNAN, Advocate for the petitioner, SRI.K.V. SOHAN, STATE ATTORNEY for R1, R2 & R4, SRI.MURALI PURUSHOTHAMAN, STANDING COUNSEL for R3 and of SRI.T. NAVEEN, STANDING COUNSEL for R5, the court passed the following:



ORDER

Hrishikesh Roy, C.J.

The learned Adv.Sri.M.Kannan appears for the petitioner. Sri.K.V.Sohan, the State Attorney accepts notice for the respondents 1, 2 and 4. The learned counsel Sri.Mulari Purushothaman represents the *Election Commission of India (*respondent No.3). Sri.T.Naveen, the learned Standing Counsel appears *Kerala State Pollution Control Board* (respondent No.5).

- 2. This Public Interest Litigation (PIL) is filed by citizen, seeking prohibition in the usage of *Poly Vinyl Chloride (PVC) Flex Boards*, a key source of pollutants, in the forthcoming Lok Sabha Election, by the political parties/candidates. The petitioner contends that the use of such PV Flex Boards will be in negation of the *Environment (Protection) Act, 1986* as well as the *Plastic Waste Management Rules, 2016* not to mention the violation of the rights of the citizens, under *Articles 21* and *48-A* of the *Constitution of India*, for a clean and safe environment.
- 3. In his turn, the learned counsel Sri.Murali Purushothaman representing the *Election Commission of India* produces the copy of the communication dated 26.02.2019, addressed to all recognised National/State Political Parties, which requires everyone to make the forthcoming election eco-friendly, and opt for elimination of single-use plastic materials in the election campaign. In this connection, Ministry of Environment, Forest and Climate Change has approached the Commission vide letter No.12/79/2018-HSMD (Pt.) dated 17th January, 2019, (copy enclosed) with the request to impress upon all concerned to take up sustainable practices and try using alternate option to single-use plastic during elections. It, inter-alia, mentions:-

"A lot of the campaigning material including posters, cutouts, hoardings, banners, political advertisements, etc., is made of
plastic. After the elections, the campaigning materials, are
discarded and become waste. Such single-use plastic waste
generated during campaigning does not get collected and causes
choking of drainage and river systems, ingestion by stray animals,
land and water pollution, open air burning, etc. Leading to adverse
impacts on human health and environment. Some of these plastics
are Poly Vinyl Chloride (PVC) based, which produces toxic
emissions on burning.

A number of alternate options to use of plastic in campaigning material are available such as compostable plastics. Natural fabrics, recycled paper material, etc. which have a lesser environmental impact. Such materials need to be promoted as a sustainable and environmentally sound management practice. The upcoming General Elections present an excellent opportunity to introduce a behavioural change in election campaign and to promote sustainable practices."

Your attention is also drawn to Para 3 of Commission's instructions No.509/241/ECI/LET/FUNC/JUD/RCC/2011 dated 20th April 2018, which specifies that

"The Solid Waste Management Rules, 2016 and the Plastic Waste Management Rules, 2016, and other applicable laws in this regard are hereby adopted for disposal of the campaign material by the local municipal authority and the cost for the same shall be recovered from the candidates or political parties, as the case may be, in accordance with the polluter pays principle"

Accordingly, the Commissioner reiterates that all political parties should take adequate steps and measures to not use single-use plastic as campaign materials (posters, banners etc.) during the elections in the interest of human health and environment.

4. Besides the above, this High Court in other proceedings has issued direction for removal of unauthorised PVC Flex Boards within the limits of various local authorities in the State.

5. Taking note of these developments and the recent direction issued by the Election Commission of India, the matter is admitted. We also deem it appropriate to order that all candidates and the National/State Political Parties must strictly adhere to the aforequoted guidelines of the Election Commission, so that only the eco-friendly materials are used during the election campaign and there is no use of PVC Flex Boards and other such non bio-degradable materials as campaign material, in the State of Kerala.
